1. Intellectual property

The promotion, presentation, sale, transport-storage, delivery and possible return of our products displayed on this website as well as the protection of your personal data and the security of your transactions are governed by these terms of use, which we invite you to read before navigating Boutiquedoptique.eu and making your purchases. Your navigation on Boutiquedoptique.eu as well as the realization of any transaction or communication with our company means the unconditional acceptance of these terms of use by you. In case of your disagreement or reservation about part or all of these terms you can send your relevant e-mail to info@boutiquedoptique.eu before you navigate or complete the transaction, otherwise you accept all the terms is unreserved.

2. Personal data

Boutiquedoptique.eu allows you to save in your account products that interest you. We use information from the products you are looking for, seeing and storing to show you results that may interest you most as well as to alert you to opportunities that may interest you.

Through your account settings you can choose which data you will share with us and manage your preferences regarding our communication with you and promotions.

4. Shipping and billing details

If you make a purchase through Boutiquedoptique.eu, we will ask you for the pricing and shipping details of the products you will buy. The invoicing data is used for the issuance of the receipt or invoice and is stored securely by Boutiquedoptique.eu, which is accessible only to specialized staff of our store.

In order to be able to process your order, we share the shipping details with the transport company, where it will deliver your products.

If you choose to pay by card, your card details are not stored by Boutiquedoptique.eu, they are registered in the payment form of the cooperating bank.
